2.1 Project summary and results

Project summary and results

Project summary (from the project document)

Department of Psychiatry and Mental Health, Institute of Medicine (IOM), Tribhuvan University (TU) and Department of Adult Psychiatry, Institute of Clinical Medicine, University of Oslo (UiO) are together applying for a project to collaborate in education and research in mental health which will enhance the quality of higher education in Norway and Nepal. IOM, TU is supported by Kanti Children Hospital, Child Workers In Nepal, For Utvikling (FORUT) while UiO is supported by University of Bergen, University of Tromsø and Norwegian Psychiatric Association's Board of Transcultural Psychiatry & Global Mental Health. The need of development of highly educated mental health professionals has been emphasized bythe government and experts of Nepal. Similarly, in Norway, there is a growing need to include crosscultural aspects in training of mental health professionals due to an increasing diverse populations belonging to different cultures. The collaboration between these Universities and their supporting partners will create an excellent opportunity to promote mobility of 51 students (master & PhD) along with visit by academic personnel in both directions. In addition, organizing international seminars, guest lectures and courses, curriculum reviews of master programs, writing up of a new PhD curriculum in

Nepal, developing common research projects and common supervision of master and PhD students in both countries will be the part of the program. Amending two decades old Master curriculum and starting a PhD program at IOM, TU will be an important outcome and a breakthrough in mental health education in Nepal. Women, underprivileged and indigenous populations will be given higher preference in the project in both countries. Norwegian students and staffs will also get a unique opportunity to learn from a resource-poor country and be able to establish some common research projects. The project has been structured to be sustainable for the future.

Project summary and results

Department of Psychiatry and Mental Health, Institute of Medicine (IOM), Tribhuvan University (TU) and Division of Mental Health and Addiction, Institute of Clinical Medicine, University of Oslo (UiO) are collaborating in education and research in mental health since 2019 with an aim to enhance the quality of higher education in Norway and Nepal. IOM, TU is supported by Kanti Children Hospital, Child Workers In Nepal, For Utvikling (FORUT) while UiO is supported by University of Bergen, University of Tromsø and Norwegian Psychiatric Association's Board of Transcultural Psychiatry and Global Mental Health. The collaboration between these Universities and their supporting partners has created a unique opportunity to promote mobility of over 50 students (master & PhD) along with visits by academic personnel and high level officers in both directions. This will cover disciplines like adult psychiatry, clinical psychology and child and adolescent psychiatry. In addition, organizing international seminars, quest lectures and courses, curriculum reviews of master programs, writing up a new PhD curriculum in Nepal, developing common research projects and common supervision of master and PhD students in both countries will be the major activities of this collaboration. Amending two decades-old Master curriculum and starting a PhD program at IOM, TU will be important milestones and breakthroughs in mental health education in Nepal. Women, underprivileged and indigenous populations will be given higher preference in the project in both countries. Norwegian students and staff will also get a unique opportunity to learn from a resource-poor country and be able to establish some common research projects with Nepal. The high-level visit from TU in 2019, curriculum review of Master program in psychiatry and psychology in 2019-2020 including enrollment of 2 PhDs from IOM, TU to UiO were the major activities that have been performed so far. This project has also received two years' scholarship for a full-time master student at UiO from autumn 2021. However, due to the Covid-19 pandemic in 2020, most of the mobilities were canceled and replaced by digital participation in joint courses and supervision which has shown to be an effective method. It seems that some of these challenges in 2020 will continue in 2021 as well. UiB has developed a course in global mental health that gave 30 ECT (originally planned 10 ECT) and was attended by 18 students (8 from Nepal). Moreover, we are also applying for an extension of the project to 2024 so that we can have some of the postponed activities/mobilities in that year. Eventually, total number of students visiting Norway and Nepal will be higher than originally planned if things go according to the revised plans.

Project progress and deviations 2020

COVID-19 pandemic has badly affected our project plans in 2020. All the mobilities except for one PhD student could not take place due to the pandemic and the imposed restrictions both in Norway and Nepal. The Ministry of foreign affairs strongly advises against all travels outside of Norway. However, we were able to continue some of the activities by using online platforms. For example, several meetings, supervisions, common teachings, and seminars were run through zoom, skype, viber, etc. As DIKU has approved our project to reallocate some of the budgets to build a better IT infrastructure at our collaborating institution, IOM TU, this has further helped us in using online solutions- This has ultimately been a good way to partly replace physical mobilities. Further, due to all these obstacles caused by the pandemic, staff at all the partner institutions had to work more on this project. Allowing us to use more on administrative and salary costs in 2020 has also helped us.

- 1. Planned activity in 2020: Visit by 4-5 delegates to TU and 2 from KCH to UiT Actual activity in 2020: Due to the start of COVID-19 pandemic in early 2020, we were only able to arrange one visit by the Faculty Director, Faculty of Psychology, UiB in February 2020 in connection with the Anual Project Meeting in Kathmandu. Similarly, the planned visit from Kanti Children Hospital to UiT in May 2020 got canceled for the same reason.
- 2. Planned activity in 2020: 2nd APM in Kathmandu
 Actual activity: Annual Project Meeting was organized in Kathmandu from 17-18th February 2020. All the
 partners were represented in this APM where we went through the activities that were carried out in 2019
 and the activities that were planned for 2020. After series of discussions, we agreed to make some minor
 adjustments regarding the number and duration of the stays and then inform DIKU about it.
- 3. Planned activity in 2020: Revision of Master curriculum and endorsement: Actual activity: Several meetings were organized for revision of the curriculum of MPhil Psychology and MD Psychiatry and final recommendations have been submitted to the higher body of IOM, TU for final approval.
- 4. Planned activity in 2020: 2nd PhD admission and mobility to Norway (3 M): Actual activity: Sagun Pant, a permanent faculty at IOM, TU has been admitted to PhD program at the Faculty of Medicine, UiO. He has had series of meetings with his supervisors in Kathmandu. There have been several zoom meetings where his project proposal was finalized and applied for admission to UiO. His project has also got approval from REK in Norway and Ethical Board (NHRC) in Nepal so that he is now ready to go for data collection. His plan to visit UiO in Autumn had to be canceled due to the ongoing pandemic in Nepal and Norway.
- 5. Planned activity in 2020: Mobility of 5 MD Psychiatry students from TU to UiO for 1-2 months Actual activity: As informed to DIKU in June 2020, mobility of 5 students from IOM, TU to UiO could not take place because of the pandemic and the measures against the pandemic imposed in both countries. After DIKU's approval, we have used some of the funds to build up IT infrastructure at IOM, TU so that we could use digital and online platforms for common teaching and supervision. This has partly replaced physical mobility.
- 6. Planned activity in 2020: 3 MPhil Psychology students from TU, Nepal to UiB, Bergen for 2 months and Mobility of 3 Master students (psychology) from Norway (UiB) to Nepal.

 Actual activity: Centre for crisis psychology in Bergen facilitated early in 2020 to digitize their course, and hosted a very successful semester in Global Mental Health (30 ECT) in the fall semester 2020, with a group of 18 students from Norway and Nepal (8 from Nepal, 10 from Norway (8 from Bergen, 2 from Oslo)).
- 7. Planned activity in 2020: Mobility of 2-3 Master students (medicine or int. health) from Norway (UiO) to Nepal (TU). Duration of stay 2-3 months.

Actual activity: Two medical students who were ready to travel to Nepal and be supervised by teachers at TU and UiO for their master thesis could not travel due to the COVID-19 pandemic. This was also in line with the travel advice from the Ministry of Foreign Affairs, Norway. These two students have

still been able to write their master thesis from a common research project between TU and UiO with common supervision. Their thesis has recently been submitted to the Faculty of Medicine, UiO. The third medical student who was ready to go to Nepal and spend 3 months at IOM, TU could not travel for the same reason.

- 8. Planned activity in 2020: Mobility of PhD student from Norway to Nepal Actual activity: We made this announcement a couple of times both through our website COMENTH and through mail to academic staff at our division. We received only one application from QUOTA sponsored full-time PhD student Rishav Koirala at the University of Oslo. He went to Nepal before pandemic and could not come back to Norway due to the pandemic and other personal reasons. He was given the PhD stipend for his stay in Nepal where he worked with his research project which is a common project between UiO and TU. He is being supervised jointly by UiO and TU teachers. Completion of his PhD is very crucial in order to start a PhD program at TU as he will be the first to have PhD from UiO and he is dedicated to help in starting PhD program at TU.
- 9. Planned activity in 2020: International conference/jt. course in Kathmandu Actual activity: This regular conference/course that we have had for several years was replaced by a Webinar on 3rd and 4th of December. In addition to TU, UiO and McGill University, we had two new partners this time, namely Kathmandu University and the Empower School of Health. We had a theme of COVID -19, mental health, women's health and culture etc. PhD students attended and presented their papers in this webinar. This was attended by around 100 participants.
- 10. Planned activity in 2020: 1st PhD curriculum meeting in Kathmandu Actual activity: We have had three digital meetings where we have discussed on PhD curriculum and its contents in order to start PhD at IOM, TU. We have also collected PhD curriculum from two renowned Universities in India, All India Institute of Medical Sciences, New Delhi and the National Institute of Mental Health and Neurosciences, Banglore, India.
- 11. Planned activity in 2020: Selection of 1 PhD candidate from KCH to UiT Ms. Srijana Adhikari , a clinical psychologist working at KCH has been selected as a candidate to PhD program at UiT.
- 12. Planned activity in 2020: Applying for 1 full-time master student from Nepal at UiO Our project has been given additional grants for one Master student from IOM, TU to UiO for 2 years full-time master study that will start in August 2021. TU has selected one candidate who is waiting for admission at UiO.

13: Aditional work:

A PhD forum of past and present PhD students in any Norwegian Universities within health sciences have been formed under the leadership of Dr. Bernadette Kumar who has been living in Kathmandu for the last three years due to her affiliation with the Norwegian Embassy in Kathmandu. This forum has had several meetings where research projects, papers etc were discussed. Besides TU, the Faculty of Medicine at Kathmandu University is also included in this forum. UiO teachers and supervisors have joined most of these meetings.

Revised work plan and timeline

We have slightly revised the work plans for 2021 and the upcoming years. We are also hereby applying for an extension of our project to 2024.

2021 activities: with some remarks

- 3rd APM in Kathmandu: Partly organized on 19th January 2021 in zoom. We are planning a physical meeting in October/November in Kathmandu.
- Continuation of PhD forum for all the PhD candidates in Nepal and Norway:
- 2nd meeting for the development of PhD program and finalization: hybrid solution- through physical and zoom meetings
- 2 PhD students from Norway to Nepal for 1 & 3 months: We will try to recruit even though the pandemic is still a challenge

- Mobility of the 1st and 2nd PhD candidate from Nepal to Norway: Both the students are currently attending some online courses at UiO and are regularly being supervised by Professors from Norway via zoom. They may visit UiO if they are allowed and need to attend courses at UiO physically.
- Mobility of 8 Master students from Nepal to Norway as explained above under 2020: As explained below under this activity, it will not be possible to carry out this activity in 2021. This will thus be replaced by digital teaching and supervision. We are also applying for an extension of the project to 2024 where this will be a major part of the project activity.
- Mobility of 3 Master students (psychology) from Norway (UiB) to Nepal for 2 months: It may be possible by the end of the year if the pandemic gets under control. Alternative plan- to attend the joint course in global mental health.
- Mobility of 3 Master students (medicine or int. health) for 2 months from Norway (UiO) to Nepal (TU): Will be tried in the fall semester despite the ongoing pandemic. Alternatively, two-three medical /master students will be supervised jointly by teachers at UiO and IOM, TU.
- Int./ joint course/conference in Kathmandu: We are planning to organize this in October/November 2021 I. An alternative plan is to organize a series of webinars as of 2020.
- 1st PhD candidate submits PhD thesis at UiO: May be postponed to 2022
- Mobility of 1 PhD student from KCH to UiT. (Ms. Srijana Adhikari is following online courses in the spring semester. If she is allowed to travel, she will be visiting Tromsø later this year for a shorter period.

Risk assessment

Covid-19 Pandemic which badly affected and almost paralyzed the whole world in 2020 is still not under full control. However, there are some positive hopes as the vaccination program has recently started both in Nepal and Norway. If this pandemic persists for a longer time and if it takes many months for a wide coverage of ongoing vaccination against Covid-19, this will create similar challenges that we experienced in 2020. However, we are better prepared to mitigate some of these challenges by using online /digital solutions.

In Nepal:

- Political unrest in Nepal: Recently, there have been some political developments in Nepal due to some internal conflicts in the ruling political party which has led to some unrest and protest.
- Several periods of complete lockdown, have slowed down academic and clinical progression for the PhD candidates, master students and supervision.
- -The granted application for allocation of funds to increase and facilitate for infrastructure at Tribhuvan University has been essential to keep the some of the academic activities going.
- -The clinical activities in the hospitals are also negatively affected.
- Loss of 1 academic year/batch at IOM, TU (Psychiatry & Psychlogy): Due to the pandemic, IOM, TU has lost almost one full academic year or batch of master students. This means that they could not take a new intake of Master students (MD Psychiatry and MPhil Psychology in 2020. This will lead to difficulties to send Master students even if this pandemic is under control later this year. However, we have great possibilities for digital (virtual) mobility and digital teaching. We are also planning to replace this mobility by extending the project to 2024 where these mobilities will be the major activities.

In Norway:

- In 2020 Universities in Norway (UiO, UiT) have offered online /digital courses for master and PhD students. This made it possible for the PhD candiates living in Nepal to participate in some courses and make a progress on their plans although it has been slowed down a bit. However, sending PhD students from Norway may be a challenge in 2021 as we had a plan of sending at least 2 students for a longer period in 2021.

Comments to expenditure 2020

Comments to expenditure 2020:

As explained previously, we were not able to carry out most of the activities in 2020 due to the pandemic. However, we were able to mitigate some of the challenges by replacing physical mobilities and courses with digital courses and mobilities. As DIKU approved our proposal to relocate some of the funds (mail from Diku 22nd June 2020) to establish better IT infrastructures at our partner University, that have been registered as the new other activities of this project. This has enabled us to do many of the things online which otherwise would have been done through physical meetings.

1. Collaboration- Local NGO and partners in Nepal and Norway:

Budget 2020: 40 000 NOK. Used 2020: Due to the pandemic it was not possible to arrange physical internal meeting for the Norwegian partners in 2020. The funds is reallocated to cover increased admin cost/reamining funds.

2. Study visits:

Budget 2020: UiO: 50 000 NOK, UiB: 25 000 UiT: 25 000 NOK, Used 2020: UiB, 21 185 NOK, Diff 3815 NOK, Remaining amount/proposed change 2020: UiO: 50 000, UIT: 25 000 NOK. We apply to transfer this grant to 2022. Due to the uncertainty for the upcoming year, we find it better to carry out high-level delegates, or other project participants from UiO for a visit to collaborating partners in Katmandu in 2022.

3. Joint field courses, International course in trauma, cultural psychiatry, global mental health and child psychiatry:

Budget 2020: UiO: 40 000, UiT: 20 000, TU: 25 000. Total: 85 000. Used 2020: 85 000 is reallocated to cover the increased administrative cost, remaining funds for 2020.

4. Joint teaching and supervision:

Budget 2020: UiO: 27 000, UiB: 20 000, TU: 20 000, Total: 67 000, Used 2020: UiB: Used: 23177. Remaining amount/Proposed change 2020: 43 823 we ask to reallocate this amount to cover increased admin cost and remaing funds 2020.

5. PhD forum of past and current PhD students:

This is a very important activity where involved students/faculties have to travel inside Nepal for meetings of PhD forum. We hereby apply to get the reallocated funds from the post "PhD curriculum review", to cover this post. If the application for extension gets approved, we also apply to cover expenses in 2024, listed in the column for 2023. Total: budget 60 000, 15 000 per year.

6. Master student mobility from Nepal to Norway:

Budget 2020: UiO: 148 000, UiB: 96 000. Total: 244 000, Used 2020: 100 000 from UiO and 50 000 from UiB were reallocated according to the approved application to establish a better infrastructure at TU. Budget and Expences are listed under new activity "Increased infrastructure at Tribhuvan University". Remaining amount/Proposed change 2020: Remaining a total diff: 94 000. As an effect of the pandemic, TU has lost one academic year due to the lack of recruitment of master students to the University. Therefore they don't have any 1 st year master students this year, and can not send any master students to Norway. We ask to reallocate this with the budget for 2021, to make a new distribution in total. Detailed overview are specified in the comment field. A total from 2020-2021: 94 000 + 244 000 (+ some remaining amount distributed to this post). Therefore we apply to transfer this amount to 2024, listed under 2023, and for a new distribution to also cover some mobility in 2024, if our application for extension gets approved. Diff + 14 000. We apply to reallocated this to cover increased admin cost/ remaining funds 2020.

7. PhD students from Nepal visiting Norway:

Budget 2020: UIO 140 000, Used 2020: After the approved application, we reallocated 16 000+ 30 000 to cover laptops and publishing fees. This is listed under other activities "Eqiptment and publishing fee for PhD students" 46 000. Remaining amount, proposed change 2020: UiO: 140 000 - 46 000 = 94 000. We apply to reallocate 50 000 of the amount to facilitate better infrastructure at Kanti Hospital, listed under a new activity "Increased infrastructure at Kanti 2021". For the remaining 44 000 we apply to reallocate this to support increased admin cost and remaining funds

8. PhD students from Norway visiting Nepal:

Budget 2020: UiO: 48 000. This 48 000 was reallocated to cover increased administrative cost in 2020. We have changed this activity with 2021's activity since PhD student could stay in Nepal for 6 months in 2020, instead of 2021. Total budget allocated for 6 months stay: 75 000, He did not need travel costs, total amount used for 6 months scholarship: 60 000. The remaining amount: 15 000 NOK, remains in the post for 2021.

9. Students Attendance at conferences, courses for PhD students:

This was approved by DIKU as mentioned in annual report from 2019. We are asking to move the total amount to 2022 as we were not able to use this due to the pandemic in 2020, and it is uncertain how much activity is possible in 2021. Listed in the budget collumn for 2022.

10. Annual project meeting:

Budget 2020: UiO: 20 000. UiT: 20 000, TU: 15 000. Total: 55 000. Used 2020: The Annual project meeting was organized in Katmandu 17-18 February 2020. UiO used 20 173 NOK on travel and accomondation. UiT used: 24 259. Meeting cost from the host institution TU in Katmandu were 15 841 NOK. Remaining amount/proposed change 2020: Diff - 5273.

11. PhD curriculum development:

Budget 2020: UiO: 60 000, TU: 10 000, total: 70 000, Used 2020: 60 000 is reallocated to cover the new post "PhD forum for PhD candidates" if our request is granted. 10 000 is reallocated to cover increased admin cost, remaining funds.

12. Revision of Master curriculum by a joint team:

Budget 2020: UiO: 20 000, UiB: 20 000, TU: 42 000. Total: 82 000. Used 2020: Due to the pandemic it was not possible to implement any travels from Norway, spring 2020. Tribhuvan University was still

able to have necessary internal meetings during 2020, that require meeting allowances and additional meeting cost according to submitted receipts. The total cost: 11 554 NOK in 2020. Subtracted from the budget (42 000- 11 554)= 30 446. + UiB: 20 000, UiO: 20 0000, this remaining amount equals a total of: 70 446, which is reallocated to cover the increased administrative cost for 2020.

13. Egiptment and publishing fee for 2 PhD students at Tribhuvan University:

Approved reallocation based on application in email from Diku on 22nd June 2020 for PhD students at UIO/Tribhuvan University. Total amount used for 2 laptops - 12 500 (due to negotiated price between the supplier and TU, the laptop price was lower than estimated). Total amount used for Open Access publishing fee at BioMed central, Dhungana: 21 325 NOK. Difference: 46 000- 33 825 = 12 175 NOK - We apply to reallocate 20 000 to cover expenses for the new PhD student, started in january 2021. This concern ethical approval that wasn't accounted for in the budget and laptop equals what the other PhD student at TU got due to the pandemic: (higher price for the laptop, since Kanti Hospital doesn't have negotiated price for laptops as TU had).

14. Increased Infrastructure at Kanti Hospital:

Based on application from UIT and Kanti hospital for a total of 46 388 NOK in order to establish IT infrastructure similar to what has been done at IOM, TU. We apply for a total of 50 000 to ensure any difference in currency between the budgeted amount and invoice withdrawal.

15. Increased Infrastructure at Tribhuvan University, Department of Psyhcology and Pshyciathry: Refer to the email from Sidsel Holmberg, DIKU on 22 June 2020, DIKU approved reallocation to mitigate the effects of the pandemic. This was used to facilitate office setup and IT infrastructures such as computers and overhead projectors etc. Total amount used for increased infrastructure: 145 398 NOK of 150 000 approved Amount.

Difference: 4602 NOK- We ask to reallocate to cover remaining funds.

16. Salary, remuneration of consultants and indirect costs:

Increased from 13% to 40%. Total amount that we had allocated under this heading after an agreement between the collaborating partners for the whole period was: 163 480 NOK per year, thsi was distributed as follows: UiO=40%, UiB=15%, UiT=10%, TU=30%, Kanti Hospital=5%. According to the approved reallocation for increased overhead to 40% for 2020, we made an adjustment as follows: UiO= 35%, UiB=20%, UiT=4%, TU= 35%, Kanti/Forut=6%. The reallocation was more than helpful for all the main partners as there has been increased work for administrative and scientific staff for all collaborating partners. We increased this within the budget for 2020 and have shown as expenses. This was thus increased from 163 480 NOK to 470 592 NOK (40%). Real amount 473 354 withdrawed due to currency difference.

Comments to the budget

- -We refer to our email communication on 22nd June 2020 where we informed about the challenges in mobilities of students and teachers due to the Covid-19 pandemic and submitted alternative plans where we requested to reallocate some of the funds to establish a better IT infrastructure at our partner institutions. DIKU allowed us to reallocate 150000 kr + 46000 kr for this purpose. We have presented the real costs under the other activities (Increased Infrastructure at Tribhuvan University, Department of Psychology and Psychiatry and Equipment and Publishing fee for 2 PhD students at Tribhuvan University).
- -We have also cut down from the budget allocated in 2021 from several posts where we think that we can not have full mobilities in 2021 due to the ongoing pandemic. We are thus applying for an extension of the project to 2024 where we can prioritize the mobilities of students, faculties, and other activities which were and will be affected by the pandemic. A separate email will also be sent.
- Since there is not yet possible to have an own column for 2024 activities, we have done as advised by DIKU, and have transferred the reallocated amount and added it to the post for 2023. This additional amount will cover basically the mobility of the master students in both the directions and some overhead costs as the activities in 2024 will be less than in the former years.
- We would like to propose to use the remaining funding for the following activities in 2020, and upcoming years. We hope DIKU accepts it. Balance 467 714

309 874 is reallocated to increased admin cost (163 480 originally admin cost - 40 % increase 473 354 new administrative amount 2020).

89 783 is reallocated to cover admin cost, if our application for extension to 2024 gets approved.

60 000 is reallocated to cover a new activity called "PhD forum" which is very important activity with very low costs, if it's approved by Diku.
