Item 1- 1/12 Presentation of the new LAMU: BIO/NCMM.

- Since BiO and NCMM cooperate in daily work it has been decided that BIO/NCMM run a cooperative LAMU. Elin Kaurstad will represent the employer and Ingrid Guldvik the employees at NCMM. The balance of members BiO/NCMM will depend on the expanding of NCMM.

Item 1- 3/12 Briefings

- Summer – fire-alarm at NCMM. The sound of fire alarm is too weak in cold room. A summer has been ordered. Forskningsparken is responsible for the installation.
- Fire-detectors in the new cell- and BT-lab. Due to rebuilding new detectors have been ordered. Forskningsparken is responsible for the installation.
- Fire detector in the server room is installed.
- Accident in the lab BiO. Due to the rebuilding of the cell lab one employee had a serious fall in some left behind planks in the corridor. The fall caused serious pain for 4 weeks, but no sick leave. We have to be very careful concerning work in areas where people are staying.
- Mouse lab The technical installations after instructions from Mattilsynet are finished, but we have to change the fire detector due to the humidity.
- New cell lab is finished. The cell lab for Lentiwork is under establishment. We need some more equipment.
- Lab coats. Liv is still working with the problem to get disposable coats for the cell-lab. We need coats not too expensive and one size that can fit different people.
- Plan of action 2011 (CLP) The joint meeting about CLP and ECO-online is an unsolved issue, but some has got instruction.
- Report to UiO and plan of action 2012. The UiO has not asked for a plan of action from the local LAMUs for 2012.
- IP –telephones. They starting at NCMM spring 2012. NCMM avoid buying new telephones for analog trafficking. They can now invest directly on IP. BiO will be finishes within 2013. This requires wires for more data traffic, but BiO has good capacity. IT has the responsibility for connection.
