

Report 2 LAMU for BiO and NCMM, Monday, 08.06.15 at 9.30-11.00

Item 2- 1/15 The LAMU-report 2 from **18.03.15** was approved with minor corrections.

Item 2- 2/15 Short briefings.

- The central HMS-staff has been expanded with 2 persons – advisors for emergency preparedness
- Local plan for emergency preparedness. BiO and NCMM will put up a local plan for emergency preparedness. For fire and medical help people shall call the emergency-number for fire and ambulance and then the University's Security and Alarm Centre 22 85 6666. For burglary and threats call the University's Security and Alarm Centre 22 85 6666 and then the police. Then call people on the local list.
- Concerning use of methanol and 3% Formaldehyde on the Hamilton platform in the HTS-lab. Knut Andresen at UiO has been contacted for an assessment and he will go forward with local measurements.
- Facilitating workplace – 4 assessments done by the UiO physiotherapist. One nearly finished and three are in process for precautions.
- There has been a discussion about handling of GMM-waste at UiO. Some meant that the autoclaving at 121 degrees for one hour was not sufficient enough to destroy the plasmids. Jorun Solheim offered to do some tests. The results attached to agenda. The PCR-product for the plasmid and the cultivating tests were all completely negative for autoclaved samples. Rolf Dalseg at the Directorate for Health confirmed autoclaving as a safe procedure.
- The minus 150 freezer is back, but turns out not to be repaired. Liv in contact with the supplier
- Mattilsynet has been on inspection for the aquarium facility. We are now waiting for the approval.
- Old common chemicals are now sent out. Especially a lot of old acids have been reduced. We have just kept Sephadex, some dyes and carbonates and acids that we know are still in use. We will ask the groups not to buy acids on their own, but use the storage we already have available.

Item 2- 3/15 Dates for safety inspection and ledelsens gjennomgang/ management review 2015
The management review will be carried out June 29th. The safety inspection will take place September 23rd for BiO and 24th for NCMM.

Item 2- 4/15 Cleaning of the labs.

We will urge the labs to do cleaning before the safety inspection in september

There are some benches that are a little too high in flow, especially in room 51054. The problem is that they during the year turns to too low and get adjusted.
