Item 1-3/17 Minutes from meeting **16.06.17** were approved

Item 2-2317 Short briefings

- The Faculty of Medicine has invited all LAMU-members to the course "IA-work in practice" on 22.11.17
- The web courses "Gas security", "Handling of chemicals, regulation and responsibility" and "How to use Eco-online" are available on UiO web-page, both in Norwegian and in English. Please remind new staff to go through those courses that are relevant to them.
- The emergency showers were tested on 04.10.17; there are 2 at E3, 1 at E2 and 4 at D3. They all worked fine.
- Follow-up on the safety inspection 2016 with focus on chemicals and CLP-labelling; CLP-labelling of all chemicals with old pictograms was finished in September 2017.
- New Liquid Nitrogen Dewar: The Sekulic group has installed a 196L tank with 15 bars pressure on E2. It is connected to the G2-S and HDX instrumentation in room 42150 with pressure 1 and 7 bar. After the nitrogen-compressor is installed, this Dewar will only be used as an extra supply when needed.
- Freezer minus 80 on E2; New freezer was installed on guaranty 03.10.17
